What happened last week?

- Egyptian President Abdel Fattah Al-Sisi paid a visit to Ankara upon the invitation of President Erdoğan. 17 agreements were signed between Egypt and Turkey. Erdoğan had said that it was impossible for him to meet with Sisi, who overthrew the Muslim Brotherhood government in Egypt with a coup d'état.
- In Cankurtaran neighbourhood of Hopa district of Artvin, citizens who intervened against those who cut down trees for the construction of an 'accommodation facility' were opened fire. In the attack, a nature defender named Reşit Kibar was killed and two citizens were wounded. Muhammet Ustabaş, who murdered Reşit Kibar, was arrested; Fikret Merttürk, who owned the gun and was present during the attack, was released on judicial control conditions. Kibar's funeral was held with the participation of hundreds of people; the timber workshop belonging to the family of the perpetrator Ustabaş was set on fire.
- The assets of the Migration Monitoring Association, whose executives were acquitted in the trial on charges of illegal organisation membership, were frozen due to the association's alleged links with the PKK/KCK organisation. The closure case against the association is still ongoing.
- In the trial of 28 suspects, including Dilan Polat and her husband Engin Polat, who were arrested on charges of money laundering and establishing an illegal betting gang and were sentenced to imprisonment for up to 40 years; arrested defendants Engin Polat, Sezgin Polat, Kürşat Polat and Ahmet Gün were released.
- US warship docked at Izmir harbour. Two US soldiers wandering in Izmir bazaar were detained with sacks on their heads by 12 youth members of the Turkish Youth Union. Ten of the detained youth were arrested.
- The 3-year road map of the Turkish economy was announced. According to the medium-term plan shared with the public, the inflation target was raised while the growth target was lowered.
- At the graduation ceremony of the Turkish Military Academy, newly graduated soldiers gathered in the area after the official programme and chanted 'We are the soldiers of Mustafa Kemal'. The video caused discomfort in circles close to the government; the Ministry of National Defence announced that an investigation was launched against the students concerned.
- Hakim Lokman, a Kurdish businessman from Duhok in Iraqi Kurdistan Regional Government, was attacked by 12 people in Istanbul for speaking Kurdish; Lokman was stabbed in the heart and died.



Two trade unionists detained

Independent Mine Workers' Union President Gökay Çakır and the union's Organising Coordinator Başaran Aksu were detained when they tried to go to the front of the mine to support the miners laid off by Fernas Mining in Soma.



A citizen was detained in a sermon dispute

The fact that the Directorate of Religious Affairs did not mention Atatürk's name in the 30 August sermon turned into a controversy in a mosque in Gaziantep. A member of the congregation who asked the imam to recite Fatiha for Atatürk was detained because another member of the congregation said 'Fatiha cannot be recited for the soul of an infidel'.

In Islamic religious terminology, an 'infidel' is a person who is considered to have apostatised by committing blasphemy or who has never been a Muslim.



Lawyer Dilek Ekmekçi arrested

Lawyer Dr Dilek Ekmekçi was detained and arrested on charges of slander and insulting a public official on the pretext of her social media posts. In the post subject to arrest, Ekmekçi had asked questions about the relations between Presidential Chief of Staff Hasan Doğan and İsmail Kartal, with whom Ankara Chief Public Prosecutor Gökhan Karaköse had taken a photograph.

Ekmekçi had filed a criminal complaint against some executives of the Nationalist Movement Party (MHP) and the Grey Wolves' Hearths on the grounds that they had played a role in the murder of Sinan Ates, former President of the Grey Wolves' Hearths, and had threatened him.



Intervention against 1 September demonstration in Adana

The police intervened the group gathering in Adana to make a demonstration for 1 September World Peace Day. IHD Adana Branch Chair Yakup Ataş and IHD Adana Branch Executive Hasan Karabulut,

who were wounded during the police intervention, were taken to hospital for treatment after the protest.



Party statute warned of 'unconstitutionality'

Ankara Chief Public Prosecutor's Office sent a warning to the Socialists Party (SOLDEP) and demanded the removal of the phrases 'The party defends the constitutional and legal guarantee of the fundamental rights of oppressed nations, especially the Kurdish people' and 'The right of nations to

self-determination' from its statute. In its statement, the prosecutor's office claimed that these phrases contradict the Constitution.



Intervention against Menemen Municipality workers' protest

Workers who were dismissed by Menemen Municipality wanted to make a statement in front of the municipality building on the 101st day of their protest. The police did not allow the workers to march and dispersed the group with an intervention.



No arrests in 1 May protests

The last 4 detainees in the group detained after the Istanbul 2024 1 May demonstrations were released by the court.



Journalist Güleş acquitted

Mezopotamya News Agency (MA) reporter Mehmet Güleş was acquitted of 'making propaganda for a terrorist organisation' on the grounds of his social media posts at Diyarbakır 4th Assize Court.
