# What happened last week?

- Fatma Sümeli, a patient who applied to Siirt Training and Research Hospital for hearing problems, was not given the necessary hearing test because she 'did not speak Turkish'. The incident reminded the debates on the need for health services in mother tongue.
- While Turkey continues to avoid result-oriented policies and strategies regarding the climate crisis, news and images of 'sinkholes' in the Konya plain continue to increase. In the 2024 performance programme of Konya Metropolitan Municipality, the share allocated from the budget for drilling new water wells for agricultural irrigation has increased 6 times in one year.
- With the start of the new academic year, the debate on 'public schools collecting donations from parents' is back on the agenda. Although the Ministry of National Education claims that 'it is not possible for public schools to charge fees', the press and parents' associations report that public schools demand between 5,000 and 200,000 liras from parents "due to budget shortfalls". It is claimed that in some schools, parents and even students take turns to do the cleaning work.
- Fenerbahçe Sports Club Congress Member Kurdish businessman Arda İlaldı announced that he was not penalised in the disciplinary committee to which he was referred after his statements 'We are waiting for Kurdistan'.
- A 'Big Family Rally' was held in Istanbul Saraçhane on 15 September demanding 'banning LGBTI+ propaganda and organisation'. In the mosque courtyard close to the area where the hate rally was held, SPoD distributed donuts in memory of Ahmet Yıldız, who was murdered by his family for being gay.
- It was revealed that Vezir Mohammad Nourtani, an Afghan worker who worked in an unlicensed mine and whose body was found burnt, was murdered while he was still alive on the instructions of the boss, saying 'he has no identity, let him be burnt'.
- On the 29th day of Emine Şenyaşar's vigil for justice at the Grand National Assembly of Turkey, police prevented her from entering the main building through the turnstiles in the opposition garden of the Parliament. Parliament Speaker Numan Kurtulmuş had telephoned the Şenyaşar family, who had started a protest at the Parliament demanding justice, and told them that the protest would damage the reputation of the Parliament.



# Journalist Mamedoğlu testified

Journalist Medine Mamedoğlu testified within the scope of the investigation launched on the charge of 'publicly disseminating misleading information' due to her social media posts about the fires that broke out between Mardin Mazıdağı and Diyarbakır Çınar districts in June

2024. Although state authorities claimed that the fires, which killed 15 people and injured 78 others, were caused by villagers burning stubble, professional organisations investigating the region stated that it was highly probable that the fires were started due to neglected electricity distribution lines.



# Nature defenders in front of the judge

The first hearing of the lawsuit filed against Süheyla Doğan Ünal, Emine Çelik Adıgüzel, Filiz Taşezen, Seyhan Yüksek and Meryem Esenay Hacıosmanoğlu, members of the Kazdağları Association for the Protection of Natural and Cultural

Assets, due to the press statement made on 20 June 2023 against the ban of the Kazdağları Ecology Festival by Bayramiç District Governorate, on the charge of 'opposing the Law on Meetings and Demonstrations' was held at Bayramiç Criminal Court of First Instance. The trial will continue on 5 November.



# Journalist Abdullah Kaya's trial begins

Journalist Abdullah Kaya, who recorded and reported on a village guard voting with his gun while covering the general elections in Diyadin district of Ağrı on 14 May 2023, appeared before the judge for the first time in the case against him on charges of 'unlawfully obtaining and

disseminating personal data'. During the hearing held at the Diyadin Criminal Court of First Instance, the village guard stated that he 'did not file a complaint'; the court set the next hearing for 21 February.



# Farisoğulları sentenced to 5 months in prison

Former Peoples' Democratic Party MP Musa Farisoğulları was sentenced to 5 months in prison for "opposing the Law on Meetings and Demonstrations". Farisoğulları was acquitted of the charges of 'membership of an illegal organisation'

and 'propaganda' in the trial held at Diyarbakır 10th Assize Court. Farisoğulları and Leyla Güven's parliamentary seats had been cancelled due to these and similar investigations against them.



#### Peace academic detained

Peace academic Mehmet Zencir and doctor Vedia Yeşim Bayanoğlu were detained in Izmir on charges of 'making propaganda for an illegal organisation' in connection with their speeches at a conference in Diyarbakır. Zencir had been dismissed from his job at Pamukkale University by a state of emergency decree.



# **Detentions in miners' protests**

Nearly 30 miners and union lawyer Mert Batur were detained when they wanted to make a statement in front of the Ankara headquarters of Fernas Holding, the company of AKP Batman MP Ferhat Nasıroğlu. The miners continue their protests demanding the reinstatement of their colleagues who were dismissed by Fernas Mining on the grounds that they

were union members and improvement of working and occupational safety conditions. In front of the mine in Soma, 3 workers were detained with the instruction of Soma Prosecutor's Office
